After considering the queries, clarifications, recommendations and suggestions, the BAC hereby decides to include, revise, amend, delete and/or adapt the following provisions:

ITEM NO.	QUERY	BAC RESPONSE
1	Philhealth (Employer's Share) based on 365 days factor)	<b>The scheduled premium hike has been suspended</b> following PhilHealth's official announcement on January 5, 2021 that there's an "interim arrangement" put in place allowing the deferment of the said scheduled adjustment. <b>PhilHealth will still stick to the 2020 premium rate of 3%</b> instead of 3.5% until Congress is able to pass a law to make the suspension permanent.
2	If Mandatory Provident Fund (MPF) will be included in the SSS (Amount Due to Government as Mandated)	Mandatory Provident Fund (MPF) for SSS Members shall be included in the SSS portion as per approved Social Security Commission (SSC) Resolution No. 458-s.2020 dated 9 September 2020.
3	Administrative Cost	The BAC shall consider bids from interested bidders where the administrative cost is lower than what the DOLE Order requires.  As per GPPB Resolution No. 14-2012, reiterated through Resolution No. 14-2015 and Circular No. 04-2015 states that DOLE DO No. 150-16 Section 4, insofar as it imposes a minimum administrative fee of 20% of the total contract cost for Service Agreement for security services, <b>likewise runs counter to the provision of Section 31 of RA 9184 and its IRR.</b>
4	Technical Specifications	A certification that the Service Provider has <b>at least five (5) years' experience in security</b>

		<p>service with <b>satisfactory performance from clients is required.</b></p> <p><i>(Attach Certificate of Performance showing five (5) years of satisfactory performance from completed/existing contracts).</i></p> <p><i>Certificate of Performance is not necessarily from 5 different entities.</i></p>
3	Source of Funds	Source of Funds is GAA under RA No. 11639
4	Contract Price Schedule & Cost Breakdown	See Attached <b>Annex A</b>
5	Revised Omnibus Sworn Statement	<p>This form itself must be submitted. Recopying is not allowed and may be a ground for disqualification.</p> <p>See Attached <b>Annex B</b></p>
