**NCDA BOARD RESOLUTION NO. 2 S/2022**

**A Resolution Supporting the Enactment of Social Pension for Persons with Disabilities bills filed in Congress**

**WHEREAS**, persons with disabilities are vulnerable to poverty due to extra costs in accessing basic necessities and development services such as food, medicines, health and rehabilitation services, education and employment among others;

**WHEREAS**, among the strategies identified in Chapter 11 of the updated Philippine Development Plan (PDP) 2022-2028 to mitigate risks faced by vulnerable groups including persons with disabilities, is to increase social pension and expand its coverage;

**FUTHERMORE**, the updated PDP included as a strategy, the need to improve the accessibility of social protection services for persons with disabilities including social pension and social assistance;

**NOW THEREFORE, RESOLVED, AS IT IS HEREBY RESOLVED**, the NCDA Board issued this resolution in support of all legislative bills on social pension for persons with disabilities filed in the House of Representatives and Senate of the Philippines in the 19<sup>th</sup> Congress;






